### **Positive Health Outcomes**

Over the past 10 years the staff of the Detroit Healthy Start Program aimed to reduce infant mortality through the intensive case management of 3,000 unduplicated pregnant women and their families.

As a New Access Point 4,551 unduplicated patients received access to primary care, 10,580 clinic visits, and 1,434 virtual visits provided by Physicians, Mid-level Nurse Practitioners, Certified Nurse Mid-Wives, Nurses, Community Health Workers, Dentist, and Dental Hygienists through the Community Health Center Program in 2021.

As a result of the Self Measured Blood Pressure (SMBP) Remote Monitoring Program, 57% of patients identified with hypertension received control which is an improvement from a baseline of 49% prior to implementing the program in 2022.

As a result of case management and giving away glucose monitoring devices, 42.4% of identified patients with a hemoglobin AIC greater than 9 have received control. This is an improvement from a baseline of 68% of diabetic patients who had a hemoglobin AIC greater than 9.

As a result of universal screening, 96% of patients identified as positive for smoking Tobacco also received cessation education.

2020 = 2992 unduplicated patients, 3484 duplicate patients, 8149 visits, and 495 virtual visits.

2021 = 4551 unduplicated patients, 5086 duplicat patients, 10,581 visits, and 1089 virtual visits.
